

## **Renasant CCPA Privacy Policy**

This **Renasant CCPA Privacy Policy for California Residents** (Policy) is provided by Renasant Bank (also referred to herein as Company, we, or us). Renasant Bank includes any entity owned or controlled by Renasant Corporation, Renasant Bank, and a subsidiary of both or either. This Policy supplements the information contained in Renasant Bank's general privacy policy (<https://www.renasantbank.com/assets/files/F1E62KvU>) and applies solely to all visitors, users, and others who are residents of the State of California ("consumers" or "you"). We adopt this Policy to comply with the California Consumer Privacy Act and the California Privacy Rights Act amendments thereto (collectively referred to herein as the CCPA). Any terms defined in the CCPA or the CPRA have the same meaning when used in this Policy.

Consumers have the right to request that Renasant Bank disclose what personal information we collect, use, disclose, and sell (if applicable). You also have rights to correct certain information we have and limit the use or disclosure of sensitive personal information. Your rights and instructions for submitting a verifiable consumer request to exercise the applicable rights are detailed in this Policy further below.

### **Information We Collect**

We collect information that identifies, relates to, describes, references, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer ("**personal information**") or household. Personal information does not include:

- Publicly available information from government records.
- Deidentified or aggregated consumer information.
- Information excluded from the CCPA's scope, like:

personal information covered by certain sector-specific privacy laws, including the Fair Credit Reporting Act (FCRA), the Gramm-Leach-Bliley Act (GLBA) or California Financial Information Privacy Act (FIPA), and the Driver's Privacy Protection Act of 1994.

In particular, we collected the following categories of personal information from our consumers within the last twelve (12) months:

### **Use of Personal Information**

We may use or disclose the personal information or sensitive personal information we collect for one or more of the following purposes:

- To fulfill or meet the reason you provided the information. For example, if you share your name and contact information to request a quoted interest rate or product terms, or ask a question about our products or services, we will use that information to respond to your inquiry. If you provide your information to obtain a product or service, we will use that information to open, process, fulfill, originate, or evaluate the requested product or service. We may also save your information to facilitate the servicing, maintenance, or normal administration of the product or service, such as maintaining a deposit account or servicing a loan or line of credit.
- To provide, support, personalize, and develop our Website, products, and services.
- To create, maintain, customize, and secure your account with us.
- To process your requests, transactions, deposits, withdrawals, draws, and payments and prevent transactional fraud.
- To provide you with support and to respond to your inquiries, including to investigate and address your concerns and monitor and improve our responses.
- To personalize your Website experience and to deliver content and product and service offerings relevant to your interests, including targeted offers and ads through our Website, third-party sites, and via email or text message (with your consent, where required by law).
- To help maintain the safety, security, and integrity of our Website, products and services, databases and other technology assets, and business.
- To comply with regulatory requirements for collecting certain information or retaining it, such as but not limited to the Home Mortgage Disclosure Act and Bank Secrecy Act.
- For testing, research, analysis, and product development, including to develop and improve our Website, products, and services.
- To respond to law enforcement requests and as required by applicable law, court order, or governmental regulations.

- As described to you when collecting your personal information or as otherwise set forth in the CCPA.
- To evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which information held by us about our consumers is among the assets transferred.

We will not collect additional categories of personal information or use the personal information we collected for materially different, unrelated, or incompatible purposes without providing you notice.

### **Sharing Personal Information**

We may disclose your personal or sensitive personal information to a third party for a business purpose. When we disclose personal information for a business purpose, we enter into a contract that describes the purpose and requires the recipient to both keep that personal information confidential and not use it for any purpose except for performing the contract. The CCPA prohibits third parties who purchase the personal information we hold from reselling it unless you have received explicit notice and an opportunity to opt-out of further sales.

We share your personal information with the following categories of third parties:

- Service providers and contractors
- Parent or subsidiary organizations,
- Affiliates (if applicable or as specified in our Renasant Bank privacy policy)
- Joint marketing companies (as disclosed in our general Renasant Bank privacy policy)

We do not engage in sharing of personal or sensitive personal information with third parties for cross-context behavioral advertising.

### ***Disclosures of Personal Information for a Business Purpose***

We do not engage in sharing of personal or sensitive personal information with third parties for cross-context behavioral advertising.

### ***Sales of Personal Information***

In the preceding twelve (12) months, we have not sold personal information or sensitive personal information.

### **Your Rights and Choices**

The CCPA provide consumers (California residents) with specific rights regarding their personal information. This section describes your CCPA rights and explains how to exercise those rights.

### ***Sensitive Personal Information***

You have the right to limit the use or disclosure of your sensitive personal information to actions necessary to perform specific purposes provided in the CCPA. You may exercise this right to request we limit our use and disclosure of your sensitive personal information and others rights by submitting a verifiable consumer request, detailed further below.

Despite any limitation request we may continue to use sensitive personal information in order to:

- Perform services or provide goods that an average consumer requesting those services or goods would reasonably expect
- Help ensure security and integrity, if that use is reasonably necessary and proportionate
- Perform short-term, transient uses, including but not limited to non-personalized advertising shown as part of a consumer’s current interaction with us
  - As long as we do not disclose the sensitive personal information to another third party, and
  - As long as we do not use it to build a profile about you or otherwise alter your experience outside your current interaction with the business
- Perform services for us, including:
  - Maintaining or servicing accounts,
  - Providing customer service,

- Processing or fulfilling orders and transactions, verifying customer information, processing payments, providing financing, providing analytic services; providing storage or providing similar services.
- To verify or maintain the quality or safety of a service or device that is owned, manufactured, manufactured for, or controlled by us.
- To improved, upgrade, or enhance the service or device that is owned, manufactured for or controlled by the business.
- To perform other actions the CCPA regulations authorize.

We do not use or disclose to a service provider or contractor your sensitive personal information for purposes other than what the CCPA specifically allows after you exercise your right to limit the use or disclosure of that sensitive personal information.

### ***Access to Specific Information and Data Portability Rights***

You have the right to request that we disclose certain information to you about our collection and use of your personal information over the past 12 months. Once we receive and confirm your verifiable consumer request (see Exercising Your Request 0), we will disclose to you, as permitted by the degree of verification we are able to perform:

- The categories of personal information we collected about you.
- The categories of sources for the personal information we collected about you.
- Our business or commercial purpose for collecting that personal information.
- The categories of third parties with whom we share that personal information (if applicable).
- The specific pieces of personal information we collected about you (also called a data portability request).
- If we disclosed your personal information for a business purpose, a list disclosing:
  - disclosures for a business purpose, identifying the personal information categories that each category of recipient obtained.

### ***Right to Correct/Rectification***

You have the right to request we correct inaccurate personal information we have about you. See the below section on verifiable consumer requests on how to submit such a request.

When we receive such a request we will make commercially reasonable efforts to correct the inaccurate information.

### ***Deletion Request Rights***

You have the right to request that we delete any of your personal information that we collected from you and retained, subject to certain exceptions. Once we receive and confirm your verifiable consumer request (see Exercising Your Request 0), we will delete (and direct our service providers to delete) your personal information from our records, unless an exception applies.

We may deny your deletion request if retaining the information is necessary for us or our service provider(s) to:

- Complete the transaction for which we collected the personal information, provide a good or service that you requested, respond to an inquiry or process a request from you, take actions reasonably anticipated (or actions needed or requested by you) within the context of our ongoing business relationship with you, maintain or service any ongoing product or account of yours, or otherwise perform our contract or transaction with you.
- Detect security incidents; protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for such activities.
- Exercise another right provided for by law.
- Comply with the California Electronic Communications Privacy Act (Cal. Penal Code § 1546 *et. seq.*).
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when the information's deletion may likely render impossible or seriously impair the research's achievement, if you previously provided informed consent.
- Enable solely internal uses that are reasonably aligned with consumer expectations based on your relationship with us.
- Comply with a legal obligation, which may be statutory, regulatory, contractual, or may be a law enforcement or judicial obligation.
- Make other internal and lawful uses of that information that are compatible with the context in which you provided it.

### ***Exercising Your Request Rights***

Only you, or someone legally authorized to act on your behalf, may make a verifiable consumer request related to your personal information. You may also make a verifiable consumer request on behalf of your minor child, to the extent your minor child may have an account, service, or otherwise have personal information with us.

When or if you utilize an authorized agent to submit a request or the authorized agent submits a request, we will require the following to be provided to us:

- A legally valid and effective Power of Attorney naming the authorized agent as the attorney in fact or your agent, such as one meeting the requirements of California's Probate Code, sections 4000 to 4465, or
- Proof that the agent has written and signed permission from you to make the request (such as a copy of the signed permission). We will also require you (the consumer) to verify your identity directly with us and will require you (the consumer) to verify directly with us that you gave the authorized agent permission to submit the request.

You may only make a verifiable consumer request twice within a 12-month period. The verifiable consumer request must:

- Provide sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative, which may include:
  - If you currently maintain a password-protected account with us (i.e., online banking), you may make a request through that account for specific pieces of information or categories of information to which that account relates and may make correction or sensitive personal information limitation request as well. You may also make deletion requests in this manner, although please be aware information may be needed in order to administer the account and so its deletion may be exempt under the CCPA (to the extent you desire to maintain the account). You will be required to login into the account to view or access the response, and this will serve as re-authentication of your identity. For the avoidance of doubt, you are not required to create an account with us if you currently do not have one. Please review the methods below if you do not currently have an account with us.
  - If you request specific pieces of information, request deletion of information or correction of information: you must provide us with the following three pieces of information, so that we may confirm or match them with our information: Last four digits of your social security number, monetary amount in or of your account, and branch of account opening.<sup>1</sup> You must also provide us with a declaration, stating, "I, the undersigned, am making a request for disclosure of specific pieces of personal information or deletion of information under the CCPA. By signing below I certify and declare I am the

consumer to whom the information relates, am the requestor whose personal information is the subject of the request, and I make this certification and declaration under penalty of perjury.”

- If you request categories of information or sensitive personal information limitation: you must provide us with the following two pieces of information, so that we may confirm or match them with our information: last four digits of your social security number and the branch of account opening.<sup>2</sup>
- Describe your request with sufficient detail that allows us to properly understand, evaluate, and respond to it.

We cannot respond to your request or provide you with personal information if we cannot verify your identity or authority to make the request and confirm the personal information relates to you.

Making a verifiable consumer request does not require you to create an account with us.

We will only use personal information provided in a verifiable consumer request to verify the requestor's identity or authority to make the request.

For requests for deletion, if we are able to sufficiently verify your identity and respond, we will inform you of the manner in which we have deleted the information, meaning whether we have (a) permanently and completely erased the personal information on our existing systems with the exception of archived or back-up systems; (b) de-identified the personal information; or (c) aggregated the personal information.

For any request for deletion, we maintain a record of the request pursuant to California Civil Code section 1798.105(d)

For instructions on exercising sale opt-out rights, see Personal Information Sales Opt-Out and Opt-In 0.

### ***Response Timing and Format***

We endeavor to respond to a verifiable consumer request within forty-five (45) days of its receipt. If we require more time (up to 45 additional days), we will inform you of the reason and extension period in writing.

We will deliver your response in the method through which you submitted your request.

The response we provide will also explain the reasons we cannot comply with a request, if applicable. We will provide responses or disclosures to the extent doing so is not impossible or does not involve a disproportionate effort. If the response is provided electronically we will provide your personal information, to the extent technically feasible, in a format that is readily useable and should allow you to transmit the information from one entity to another entity without hindrance, commonly the formats used are Microsoft Excel or Adobe PDF.

We do not charge a fee to process or respond to your verifiable consumer request unless it is excessive, repetitive, or manifestly unfounded. If we determine that the request warrants a fee, we will tell you why we made that decision and provide you with a cost estimate before completing your request.

### ***Personal Information Sales Opt-Out and Opt-In Rights***

We do not sell the personal information of consumers. Without limiting the generality of the foregoing, we also do not sell the personal information of consumer's we actually know are less than 16 years of age.

### **Non-Discrimination**

We will not discriminate against you for exercising any of your CCPA rights. Unless permitted by the CCPA, we will not:

- Deny you goods or services.
- Charge you different prices or rates for goods or services, including through granting discounts or other benefits, or imposing penalties.
- Provide you a different level or quality of goods or services.
- Suggest that you may receive a different price or rate for goods or services or a different level or quality of goods or services.

The CCPA allows businesses to offer certain financial incentives with respect to exercising CCPA rights. However, we do not differentiate price, rates, or quality levels due to exercising any rights under the CCPA. As such, we have no financial incentive program pursuant to the CCPA.

### **Other California Privacy Rights**

California's "Shine the Light" law (Civil Code Section § 1798.83) permits users of our Website that are California residents to request certain information regarding our disclosure of personal information to third parties for their direct marketing purposes.
